Sharing of your data is strictly controlled and carried out for specific purposes; your personal details will not be used by Horse Racing Ireland or any of the above organisations for marketing purposes. Aside from those parties referred to in this notice (which may change from time to time), your personal details will not be shared with any other third party.
